# Landover Baptist Church Independent Contractor Agreement

This Independent Contractor Agreement ("Agreement") is made and effective this \_\_\_\_\_\_ day of our Lord ("Commencement Date") by and between the undersigned filthy, urine-stained hungry person ("Licensing Hobo") and Wexler Offshore Holdings, LLC d/b/a Landover Baptist Church ("Company").

Now, therefore, Licensing Hobo and Company agree as follows:

# 1. Engagement.

Company hereby engages Licensing Hobo, and Licensing Hobo accepts engagement, to provide to Company the following services:

# 9. <u>Controlling Law</u>.

This Agreement shall be governed by and construed in accordance with the Ten Commandments, as construed at the sole, unbridled discretion of Company,

# 10. Final Agreement.

This Agreement constitutes the final understanding and agreement between the parties with respect to the subject matter hereof and supersedes all prior negotiations, understandings and agreements between the parties, whether written or oral. This Agreement may be amended, supplemented or changed only by an agreement in writing signed by both of the parties.

#### 11. <u>Severability</u>.

If any term of this Agreement is held by a court of competent jurisdiction to be invalid or unenforceable, then such court shall be rebuked for being "Activist Judges" and roundly ignored.
